Funds will be used to cover closing costs for homes that were damaged by Hurricane Harvey. The GLO requires that local funds are used for title fees (title insurance, recording costs, closer fees, etc.) as the GLO will only advance funds equivalent to the home purchase price to the City. The local funds used for title fees will be reimbursed by the GLO after the closings have taken place. Funds to help cover this will come from the General Operations Fund. Second by Council Member Rashad Lewis. Motion carried unanimously.

Motion by Council Member David Shultz to approve Resolution No. 2996 allowing the City to participate in the Texas SmartBuy Membership Program through the Texas Comptroller of Public Accounts. Second by Council Member Anderson Land. Motion carried unanimously.
