Mayor Gatlin announced the opening of the Budget Workshop and turned the floor over to City Manager Denise Kelley.

Ms. Kelley went over the Budget and Financial Plan for the Fiscal Year 2020/2021 and stated, "This is a balanced operating budget including a (3%) salary increase across the board. Budget uses anticipated income from SRMPA-Cambridge to fund the debt payment for the DETCOG building. The budget does not include ANY Capital purchases. There are pieces of equipment that are needed in various departments. These have been funded in the past by funds from the Cambridge-SRMPA revenue funds.

Last year new regulations were passed preventing local governments from raising property tax rates in excess of 3.5% each year. If jurisdictions want to raise rates above that level, they must get voter approval. Our current tax rate is .3579 of which .2554 is allocated to Maintenance and Operations in the General Fund. .1025 is allocated to Interest and Sinking Fund to retire bond debt. The current assessed value is # 317,754,406. The current property tax rate would generate the following revenue IF all taxes were paid. M&O \$ 811,544.75 and I&S \$ 325,698.27 Giving a Total of \$ 1,137,243.02. If we were to increase our current rate by the 3.5 % our rates would be .3704. This would generate an increase in revenue of approximately \$ 39,719. We would keep the I&S rate the same and increase the M&O rate to .2679. The net effect for a home or business valued at \$100,000 would be an increase of \$ 12.50 over last year's rate. This is all pending on the decided decision from City Council with the direction you would like me to pursue.
