The Regular Called City Council Meeting was called to order by Mayor Randy Sayers at 6:00 PM. Mr. Raymond Hopson gave the opening prayer. All City Council members were present for the meeting.

Mayor Sayers gave the reading for a Proclamation, American Red Cross Month.

Mayor Sayers asked for questions or comments on departmental reports. None were made.

Mayor Sayers asked for Public Comments. The following were made:

- 1. Mrs. Hazel Johnson Gave her opinion of how negatively the broadband project has been handled. The integrity that all council members and mayors should uphold to, and her disappointment in Council Members Michael Daniel, David Shultz and Mayor Randy Sayers.
- 2. Mr. Jay Sharp Stated all elected officials should be held accountable for their actions.

Second by Council Member David Shultz. Motion carried unanimously.

Motion by Council Member David Shultz to approve appointing election judges for the May 7, 2022 City Municipal Election. Second by Council Member Laura Golden. Motion carried unanimously.

Motion by Council Member Anderson Land to approve the bid received from Barricades Unlimited in the amount of \$885,000.00 via Goodwin-Lasiter, Inc. for the City-Wide Street Sign Replacement Project and for the funds to come from the SRMPA Cambridge Funds. Second by Council Member David Shultz. Motion carried unanimously.

Motion by Council Member Laura Golden to approve the Interlocal Agreement for GLO Flood Buyout Property Transfers between the City of Jasper and Jasper County. Second by Council Member David Shultz. Motion carried unanimously.

Motion by Council Member Anderson Land to approve the bid received from Bright Star Solutions (Bid on file in the amount of \$1,120,400.00) Second by Council Member DeMarcus Holmes. Motion carried unanimously.

Motion by Council Member Laura Golden to TABLE appointing someone to the South East Texas Regional Planning Committee until after the City Election giving any new members a chance to be on the seat if they wish to. Second by Council Member David Shultz. Council Member DeMarcus Holmes made a Motion to amend Laura Goldens Motion to nominated Anderson Land to the committee. Second was made by Council Member Anderson Land. Mayor Sayers asked council for a vote. Those voting in favor of the motion to Table this item until after the city election were Council Members Michael Daniel, David Shultz, and Laura Golden. Mayor Sayers asked for those voting opposed to the motion and Council Member Anderson Land and DeMarcus Holmes voted opposed. Mayor Sayers stated a vote of (3) for and (2) opposed. Mayor Sayers asked for those voting in favor of the amended motion to nominate Anderson Land to the committee. Those voting in favor were Council Members Anderson Land and DeMarcus Holmes and those voting opposed were Council Members Michael Daniel, David Shultz, and Laura Golden. Mayor Sayers announced a vote of 3 for and 2 opposed. The measure passes in favor of the motion to Table this item until after the city election.

Motion by Council Member David Shultz to approve granting the authorization for David Waxman's office to bid the Sandy Creek debris removal portion of the 2016 Flood Grant 19-076-047-B700. Second by Council Member Laura Golden. Motion carried unanimously.

Motion by Council Member David Shultz to grant authorization for David Waxman's office to procure an Appraiser and a Review Appraiser for the acquisition of property for the detention pond project portion of the 2016 Flood Grant 19-076-047-B77. Second by Council Member Michael Daniel. Motion carried unanimously.

Motion by Council Member Anderson Land to approve amending the Administration Contract for the GLO-MIT Street Improvements Project 22-065-022D263. Second by Council Member David Shultz. Motion carried unanimously.

Motion by Council Member Anderson Land to postpone signing on the contract with Kramer Services Group indefinitely. Second by Council Member DeMarcus Holmes. Council Member Laura Golden requested a discussion and stated she felt it should be tabled for a while because the citizens of Jasper deserve more time to ask questions about this project. There is a lot of misunderstand about this project and we as a council can do better. Council Member Anderson Land stated he agreed and stated postponing indefinitely did not mean that council could not bring it back up some time in the future. Council Member Laura Golden thanked Anderson for his clarification to his motion. Mayor Sayers asked for a motion in favor of Tabling indefinitely. Council Members Anderson Land, Laura Golden and DeMarcus Holmes voted in favor. Council Members Michael Daniel and David Shultz voted opposed. Mayor Sayers stated a vote of 3 for and 2 against. The measure passes in favor of postponing indefinitely.

Motion by Council Member Michael Daniel to confirm anything tied to the Broadband Project financially is to come from the SRMPA Cambridge Funds. Second by Council Member Anderson Land. Motion carried unanimously.

There being no further business to discuss, Mayor Sayers adjourned the meeting at 6:54 p.m.
