The Regular Called City Council Meeting was called to order by Mayor Randy Sayers at 6:05 PM. And Mr. Robert Jackson gave the opening payer. All City Council members were present for the meeting with the exception of Council Member DeMarcus Holmes who was absent due to working out of town and Council Member Laura Golden.

Motion made by Council Member Anderson Land to approve and adopt the ordinance. Second by Council Member Michael Daniel. Motion carried unanimously.

Judge Jackson administered the Oath of Office to Council Member District # 4 David Shultz and Council Member District # 5 At-Large Rashad Lewis. District # 3 Council Member DeMarcus Holmes was absent and will be sworn in at a later date.

Mayor Sayers asked for questions or comments on Departmental Reports. None were made. Mayor Sayers asked for Public Comments. The following were made:

Mr. Billy Williford spoke regarding the building permit process to obtain a building permit. The process to get what once was a simple process is now timely and very difficult. You can no longer come to City Hall and get a permit the same day. We have been in business since 1958 and this has never in all the years of business serving the Jasper area has it ever been this difficult and timely to get a permit until now. Council thanked Mr. Williford for his comment.

Motion by Council Member David Shultz to appoint Rashad Lewis as Mayor Pro-Tem. Second by Council Member Michael Daniel. Council Member Rashad Lewis made a motion to accept Anderson Land as the new Mayor Pro-Tem. Mayor Sayers stated we have a motion already on the floor and a second. All in favor were Council Members Michael Daniel and David Shultz. Council Members Anderson Land and Rashad Lewis both abstained from voting. Council discussed the voting process and Council Member Rashad Lewis made an amended motion to appoint Council Member Anderson Land. Council Member Anderson Land second the motion. Mayor Sayers asked for a vote. Council Members Rashad Lewis and Anderson Land both voted in favor of the amended motion. Council Members David Shultz and Michael Daniel voted against the amended motion. City Attorney Michael Ratcliff suggested that council Table the item. Mayor Sayers stated we have a tie. Council discussed and agreed. Mayor Sayers stated he will break the tie and vote in favor of Rashad Lewis being the new Mayor Pro-Tem. Motion passed.

Motion by Council Member David Shultz to approve the minutes from Regular Called City Council Meeting April 11, 2022 with corrections to the Proclamation reading and the words next lowest bidder not lowest bidder regarding the LED lighting. Second by Council Member Michael Daniel. Council took a vote in favor of approving the corrected minutes. Those voting for were Council Members Michael Daniel, David Shultz and Rashad Lewis. Council Member Anderson Land voted against the motion. Mayor Sayers stated it passes 3/1 vote.

Motion by Council Member Anderson Land to approve the request for variance from Code Enforcement for Mr. Robert Jackson at 331 West Olive Street. Second by Council Member Michael Daniel. Motion carried unanimously.

Council considered the next agenda item, to consider request from Council Member Anderson Land and DeMarcus Holmes – To cancel the Broadband Contract from Kramer Services Group LLC and to instruct the City's Finance Director to make a final payment to Kramer Services Group LLC and Mr. Nathan Watkins for Consulting from the SRMPA funds for services they have rendered to date.

Motion by Council Member Rashad Lewis to postpone this item until the next meeting because it's his

first day on council and he would like time to read up on this issue.

Second by Council Member Anderson Land. Council Member David Shults made a motion to amend Rashad's motion, to postpone until a definitive date of December this year regular council meeting and to amend referring this to a committee made up of Rashad Lewis, Michael Daniel, and myself. Council Member Anderson Land stated we already made a motion. Council discussed and agreed to postpone until the next regular meeting. Mayor Sayers asked for a vote. Council Members Anderson Land and Rashad Lewis voted in favor of postponing until the next scheduled meeting. Council Members David Shultz and Michael Daniel voted opposed the motion. Council Member David Shultz made an amendment to the motion to postpone until the scheduled meeting in December with the intent of a

Motion by Council Member David Shultz to approve the Utility Pole Attachment Agreement from Lloyd Gosselink Attorneys at Law. Second by Council Member Anderson Land. Motion carried unanimously.

Motion by Council Member Michael Daniel to approve the purchase of playground equipment city wide to be purchased with Cambridge funds at the current Buy Board cost of \$453,391. Second by Council Member Anderson Land. Motion carried unanimously.

There being no further business to discuss we need a motion to adjourn. Motion made by Council Member David Shultz. Second by Council Member Michael Daniel. Motion carried we stand adjourned at 6:40 p.m.
