# NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.2554 per \$100 valuation has been proposed by the governing body of CITY OF JASPER

PROPOSED TAX RATE	\$	<u>0.2554</u>	per \$100
NO-NEW-REVENUE TAX RATE	\$	<u>0.3454</u>	per \$100
VOTER-APPROVAL TAX RATE	\$	<u>0.2929</u>	per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for CITY OF JASPER from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval tax rate is the highest tax rate that CITY OF JASPER may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that CITY OF JASPER is not proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON 09/19/2022 05:45 PM at City Hall, 460 South Main St, Jasper, TX

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, CITY OF JASPER is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the CITY COUNCIL of CITY OF JASPER at their offices or by attending the public meeting mentioned above.

YOUR TAXES OWED UNDER ANY OF THE TAX RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

$$\text{Property tax amount} = (\text{tax rate}) \times (\text{taxable value of your property}) / 100$$
